To ensure uniformity in the admission process and fee structure, the following directions are hereby issued regarding PM SHRI Schools:

- 1. Fee Structure and Admission Process:** The admission process and fee structure in PM SHRI Schools shall be the same as per normal government schools. Model Sanskriti Schools made as PM SHRI Schools shall also follow the same fee structure as per normal government schools.
- 2. CBSE Affiliation and Student Registration:** PM SHRI Schools affiliated with CBSE shall register students of Classes 9th and 11th under CBSE. Students of Classes 10th and 12th shall continue their studies under the Haryana Board until the completion of their current academic session.



Subject: Implementation of Cashless Transaction in the State for class 9th to 12th.

Reference: Direction of the State Government vide 28/71/2016-4B&C dated 23.11.2016 on the subject cited above.


It has been decided by the State Government that till further arrangement, the following procedure may be adopted by all Government schools for cashless transactions.


1. The present bank account maintained by the school in the name of Child Welfare Fund (CWF) be used for depositing of all types of fees/ funds/ board of school education, Haryana fees by the students/ parents. The fees/funds divided at present are as under:-

2. This account is to be maintained by head of the institution and proper cash book is to be maintained for all transactions.
3. All students/ parents may be guided to deposit their dues including their fees/ funds/ board of school education, Haryana fees through online money transfers such as net banking, RTGS, debit/ credit card, e- wallet, UPI and other such modes to CWF account.
4. The head of the school/ institution will transfer the amount to other funds/ board of school education, Haryana through online transaction as per Govt. instructions only.
5. Head of the institution will maintain the record of transaction expenditure of different funds in separate cashbooks.
6. The above mentioned CWF account will be a dedicated account out of which no withdrawal will be allowed in cash or through cheque against any bill related to any other fund.
7. Students may be given training regarding the use of various methods of online money transfer to deposit their fees/funds on joyful activity day. This will also help them and their parents in cashless transaction of their other expenditures.
8. The above procedure of cashless transactions for fees and funds etc. will continue till a cashless money transfer system through bank or any other agency is introduced for this purpose.
